Dear Mr. Al-Abdulla,

Following your discussion with Olivier Pardo yesterday, we confirm that our firm has been appointed by Ms. Benabderrahmane to assist and represent her husband, Mr. Tayeb Benabderrahmane, French national born on January 24, 1981, who is detained since January in Doha Central Prison.

Ms. Benabderrahmane was allowed to meet with her husband twice. She was asked by who appeared to her as police officers to bring a suitcase. She assumed that her husband was to be released but he was not and the suitcase was sent back to her. More recently, she was asked over the phone to bring a USB flash drive. Ms. Benabderrahmane is ready to proceed with such request but wants guarantees that her husband will be released.

We would like your assistance on this case to obtain Mr. Benabderrahmane's release. Please let us know how we can proceed and provide us with an estimate of your fees.
